Waiver, Release and Other Terms

I hereby agree to participate and/or engage in the use of the golf course, equipment, facilities, and programs offered by the Club upon the understanding and agreement that:

I am aware of the risks of illness or injury inherent in any golf or exercise activity. These risks include but are not limited to: being hit by golf balls, golf clubs, golf carts, or lightning; stepping or tripping in holes or other natural indentations in the ground; injury from insects, birds, snakes or other animals; pulled muscles or other sprains, strains or injuries.

I agree that I will engage in the use of the golf course, equipment, facilities, and programs offered by the Club with the express understanding that I am assuming all of the risks noted above and that I am agreeing to waive and release the Club, its employees, agents, officers, Directors, Successors, and Assigns from any and all claims, costs, liabilities, expenses or judgments, including attorney's fees and court costs (hereafter referred to as the "Claims") that arise out of or relate to my activities or the activities of my family and guests at the Club. I further agree to defend, indemnify and hold harmless the Club and its employees, agents, officers, directors, owners, successors, and assigns from and against any and all claims, costs, liabilities, expenses or judgments, including attorney's fees and court costs, that arise from or relate to my activities or the activities of my family and guests at the Club.

I agree that all claims of any kind relating to my participation or the participation of any member of my family or guest at the Club, or my or their use of any Club facilities, including but not limited to, claims for personal injuries, shall be brought exclusively in the Courts of the State of New Jersey located in Cape May County.

I understand that the Big Little 9 Golf Course and Facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the Course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of Big Little 9. I understand and agree that nothing in this Membership Agreement entitles me to any of the facilities on any particular day nor to any discount or refund on account of any limited access. I further understand that access to the course, practice facility and the restaurant and other privileges and benefits may be limited by Big Little 9 as necessary. No member is entitled to a refund or return of amounts due to damage to or condition of the golf course or any amenity. Further, Big Little 9 shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond the control of Big Little 9.

General Provisions

This Membership Agreement constitutes the full and entire Agreement between the Parties hereto and such Parties acknowledge that there is no other Agreement, oral and/or written, between the Parties hereto. Should any term, provision, covenant and/or condition of this Membership, or any clause of part thereof, be held by a court of competent jurisdiction to be invalid, illegal, void or unenforceable, it shall be deleted from this Membership Agreement, and the balance of the Membership Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated. The member's rights, privileges or interests under this Membership Agreement are not assignable or transferable.
